- The Denver Preschool Program reserves the right to terminate QI grant funding following performance review and/or evaluation if, in the sole discretion of the Denver Preschool Program, the Provider cannot meet their obligations as outlined in the 2024-2025 DPP Provider Agreement.
- Acknowledge that the Denver Preschool Program reserves the right to adjust the amount of grant funding and types of allowable expenses at any time due to budget or programmatic considerations, or if it is found the Provider had a different number of physical DPP classrooms or different quality rating level as of September 1, 2024, than the values used to calculate the funding amount.
- DPP QI grant funds can only be used for approved expenses outlined in the 2024-2025 DPP Grants and Quality Improvement Resources Agreement.
- Providers will be required to provide a report on how they utilized the grant funds.
- Should a provider end participation with DPP, full repayment of the grant may be required.
